1. The Department of Education (DepEd) Misamis Oriental, through the Government of the Philippines (GOP) under FY 2018 General Appropriations Act (GAA),¹ intends to apply the sum of *TWO MILLION SEVEN HUNDRED TWENTY THOUSAND ONE HUNDRED FIFTY ONE AND 81/100 (Php 2,720,151.81) Pesos*, to payments under the contract for the Supply, Delivery, Installation, Testing, Commissioning and Training for Various Tools and Equipment for Cookery NC II package Technical-Vocational-Livelihood (TVL) Programs of Various TVL Senior High Schools,

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. DepEd Division of Misamis Oriental, through its Bids and Awards Committee, now invites bids for the goods and services contemplated in this project and as detailed in the Schedule of Requirements and the table of Technical Specifications indicated in the bidding documents.² Delivery of the Goods is required within 60 days from issuance of the Notice to Proceed. Bidders should have completed, within ten (10) years immediately preceding the deadline for the submission of bids, at least two (2) contracts similar to the Project, the aggregate applicable contract amount being equivalent to at least fifty percent (50%) of the ABC of the lot bid for, and the largest of those said contracts is equivalent to twenty-five percent (25%) of the said ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from [The Chairman of the Bids and Awards Committee of the DepED, Division of Misamis Oriental] and inspect the Bidding Documents at the address given below during [November 20, 2018 to December 10, 2018 , 5:00pm PST.]
5. A complete set of Bidding Documents may be acquired *in the amount of* [[FIVE THOUSAND (Php 5,000.00) Pesos.] by interested Bidders on [November 20, 2018 to December 10, 2018, 5:00pm PST] from the address below upon payment of fees.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The DepED, Division of Misamis Oriental] will hold a Pre-Bid Conference on [November 28, 2018, 10:00 o'clock in the morning] at Department of Education, Division of Misamis Oriental, Division Office Conference Room, A. Velez St., Cagayan de Oro City], which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before [December 11, 2018 , 9:00 am PST]. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bidders shall submit their bids through their duly authorized representative using the appropriate forms provided in Bidding Forms on or before the deadline of opening of bids in two (2) separate sealed bid envelopes, and which shall be submitted simultaneously. A duly authorized representative shall submit special power of attorney/ a notarized certification authorizing him/her to represent the proprietor/ manager/ owner.

Bid opening shall be on [*December 11, 2018, 9:00am PST*] at [Department of Education, Division of Misamis Oriental, Division Office Conference Room, A. Velez St., Cagayan de Oro City]. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. Based on GPPB Circular 03-2016, bidders are required to submit their PhilGEPS certificate of Registration (Platinum Membership) during bid submission.
8. The *DepED, Division of Misamis Oriental*] reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
